**WHEREAS**, Republic Act No. 7277, as amended by Republic Act No. 9442, otherwise known as the Magna Carta for Persons with Disability, imposes upon the State as its duty to “advocate for and encourage respect for persons with disability” and “exert all efforts to remove all social, cultural, economic, environmental and attitudinal barriers that are prejudicial to persons with disability”;

**WHEREAS**, the Cebu Provincial Government affirms the reality that persons with disabilities or PWDs are among the marginalized and disadvantaged sectors of the society who need the government’s solicitous support and constant protection;

**WHEREAS**, the Sangguniang Panlalawigan of Cebu finds it necessary and beneficial to hold province-wide and month-long activities aimed at stimulating public awareness of and interest in all matters pertaining to persons with disabilities;
