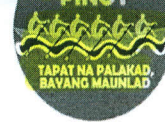

SUBJECT : 34th National Disability Prevention and Rehabilitation (NDPR)
Week Celebration (July 17-23, 2012)

By virtue of Presidential Proclamation No. 361, S. 2002, as amended by Administrative Order No. 35 S. 2002, every 3rd week of July is declared as the National Disability Prevention and Rehabilitation (NDPR) Week. The weeklong celebration which is set on July 17-23, 2012 banners this year's theme "**Mainstreaming Persons with Disabilities in Economic Development**".

In support of the nation's efforts in raising public awareness on the concerns of Persons With Disabilities (PWDs), all Local Chief Executives are hereby encouraged to extend full support and take part in the observance of the 34th NDRP Week by undertaking fitting activities such as but not limited to the following:

- Hanging of streamers in conspicuous places thereof
- Thanksgiving and Holy Mass Celebration
- Orientation on UNCRPD and RA10070
- Jobs Fair-Employers Forum
- Cultural Show
- Poster Making Contest for PWDs
- Family Fun Day for PWDs-*Paligsahan ng may "K"*
- Mobility Clinic and Medical/Dental Mission
- Livelihood Exhibits
- Tree Planting Activities
- Access to Local Radio & Television Programs

In order to highlight this year's NDPR Week celebration, this year's theme was conceptualized to contribute and promote the full employment of PWDs and to tackle barriers and gaps, facilitate stakeholder's cooperation, develop innovative approaches and support human rights-based initiatives for the economic development of persons with disabilities.

Likewise, LGUs are hereby requested to submit not later than August 17, 2012 a summative report of activities conducted using the attached reporting form for consolidation and submission to the National Council for Disability Affairs (NCDA).

All DILG Regional Directors are hereby directed to extend full support as appropriate and as necessary. The Regional PWD Coordinator shall constantly coordinate with the Regional Council for the Welfare of Disabled Persons (RCWDP) or Regional DSWD Office relative to the celebration.
